Stein Kuhnle is Professor of Comparative Social Policy at Hertie School of Governance. He completed his cand.polit.rerum de-

gree at the University of Bergen (Norway) in 1973. He was at the Brookings Institution in Washington, D.C. and at the Graduate School of Public Policy, University of California, Berkeley, on a Ford Foundation Post-Doc Fellowship in 1977. He was appointed Professor of Comparative Politics in Bergen in 1982, and chaired the Department for almost 15 years during 1983–2005. Since 2006 he has taught Comparative Social Policy and Welfare State Reform at the Hertie School, Stein Kuhnle has published widely in the field of comparative welfare state studies, and in many languages. His publications include Patterns of Social and Political Mobilization: A Historical Analysis of the Nordic Countries (Sage, 1975); Survival of the European Welfare State (ed.; Routledge, 2000); Normative Foundations of the Welfare State: The Nordic Experience (ed. with Nanna Kildal; Routledge, 2005); and The Nordic Welfare State (ed. with Chen Yinzhang, Klaus Petersen and Pauli Kettunen, published in Chinese by Fudan University Press; 2010).
